# **Squamish Trails Society Meeting January 20, 2011**

#### **Attendees:**

#### **Guest: Larry Murray - Squamish Crimestoppers**

- o <u>www.solvecrime.ca</u>, 1-800-222-8477
- Concern about property theft and vandalism around trailheads and on trails.
- Crimestoppers puts up signs on trails etc around Squamish. There are some issues with removal of crimestoppers signs, e.g. at BC Parks.
- Increasing trend in crimestoppers reporting in Squamish
- Larry Murray administers crimestoppers reports and delivers to Squamish RCMP who act on it.
- Larry suggests awareness is the best preventative measure (e.g. signage) and Larry has crimestoppers signs available
- Crimestoppers is starting a parking lot watch program monitors lots and then gives people written feedback on whether or not their parked vehicles are secure (valuable items not visible etc.)
- The Community Police Station has closed due to a lack of security (for staff etc.) and Larry urges STS and other groups to advocate for it to be opened
- Hotspots for theft are Shannon Falls, Alice Lake, Murrin, Smoke Bluffs
- Squamish has the majority (60%) of tips in Sea to Sky region
- An idea has been presented to Tourism Squamish to pair up an older adult and a youth to be ambassador / crime-watcher in key areas
- Suggestion that STS could ask Squamish Council to formally approve of crime stopper stickers on District trail signage
- o Action: put up crimestoppers link on STS website. Approved

#### Reports: Transportation Study Committee report - Carl/Ted

- Transit is shown as strong preference, as an alternative to single occupancy vehicles.
- There has been a strong focus on improving bike lanes to meet people's preferences. Want to make it as attractive as possible when whether appropriate.
- A strong point was made that the municipality needs to tap into community groups about their specific knowledge on needs. Municipality wants community 'users' to identify community connectors.
- Thursday Jan 27 public meeting on multi-modal transport study... go to "shape your future" on DoS website.
- Saturday Jan 22 there is a bus tour of future ideal nodes for proposed ideal transit routes. Meet at Shoppers Drug Mart at 11am.

Kudos to the District to clear sidewalks and bike lanes when it snows!

#### Hwy 99/Commercial Way to Brennan Park Trail - Bob

- · email from Mary Mitchell
- This project has been on the radar for a few years. STS got an environmental study done by Cascade Environmental. Would need equestrian use considerations.

- Doug suggested a meeting open to memberships of Watershed Society, Environmental Society, Streamkeepers, with STS to discuss environmental considerations and support for the trail. Perhaps Cascade could explain the findings to these multiple groups.
- Some people are sensitive about fragmentation of habitat and habitat corridors
- o Cascade has identified a "least impact" option that could be discussed.
- Possible users for the trail: new residential near Brennan Park, sports teams/rec users, continuity between Brennan Park and Business park. Could be routing to future uses and routing.
- Cost would be ~\$80k. STS would contribute only a modest amount, with other funds from DoS, businesses, etc.
- o Need to determine why and if this trail is a priority?
- The Multimodal Transportation Plan study identifies a possible overpass or underpass in the future.
- o Would business park businesses be interested in helping to fund it?
- Perhaps we could benefit from survey monkey

#### **Updates on District related issues - Bob**

As requested - not yet available from Todd Pope

- o highway improvement discrepancies
- Corridor Trail re-alignment of road barricades from Hwy 99 Mamquam bridge to past the dyke entrance
- o Corridor Trail Valleycliffe: Red Point to Clarke Drive

#### Valleycliffe Connector: letter to Ana Santos-Squamish CAN – Bob

- Squamish CAN attended in September and there have been many discussions since then. District of Squamish is now working on solutions.
- o Bob has penned a response to Squamish CAN for consideration. Letter to be sent.

# Discussion: Mamquam Blind Channel - waterfront trail & landowner's Crown Land use application (pg A28 Jan 7 Chief)

 Landowners in the area are in discussion with the District of Squamish and once it has been concluded we hope that there will be reinstated trail access.

#### **Highlands Connector - Doug**

- o From Ayr drive to Skyline Place, and then to Coho Park.
- This is on the radar, should have ownership issues dealt with and improvements as noted.

We need to keep on the radar new opportunities for connections in newly developing areas, and keeping corridors open and available.

Patrick raises that maintenance between on slough trails (Wilson Slough area) may be needed. It gets worn away by the tide. Perhaps riprap or \ bags that have spikes that can be stacked and grow vegetation.

# **Squamish Trails Society Minutes Meeting February 17, 2011**

#### Attendees:

## Guests - John Moonen & Viriginia Bird from Kingswood Developments (Developer)

- A presentation about their Mamquam Blind Channel/Scott Crescent area development:
   Kingswood + DeCook + agreement with Carney
- Anchoring the development with a National Climbing Centre (5000 sq ft) plus 5 X 1000 sq ft stores (hopefully outdoor rec focused), up to ~390 condo units on the DeCook and Kingswood Properties.
- Developer is proposing a trail under the south side of the Mamquam Blind Channel Bridge, and trail to connect with Hunter Trail, and waterfront walkway concept (DoS staff says this is critical).
- There was some question as to whether the Hunter Trail will be part of the Developer's
  obligation. Developer is planning on not rebuilding the Hunter Trail. Apparently DoS will
  be spending up to \$30K on the trail.
- They are proposing some commercial close to Hwy 99, and then residential
- STS raised that there is a long term vision to bridge from the spit
- Access and traffic will be key issues. DoS has suggested that they go up Scott Crescent and then make improvements on Clarke Drive. There will not be any u-turns etc on the highway. Bus will go right in and right out from the Highway.
- Some question about the location of the climbing centre at the Kingswood area would it be
  more appropriate closer to the Adventure Centre? Also parking at the climbing centre will
  be an issue. The climbing centre will be a for-profit interior climbing facility, and the
  National Climbing Ctr (NCC) will be a not for profit organization that operates out of the
  facility.
- They will build from the highway inward, so presumably the trail amenity would follow the same sequence.
- There will be lots of public parking demand for water access at the Mamquam Blind Channel.
   There will also be lots of parking demand for the climbing facility. Maybe some diagonal parking along Scott Crescent will be helpful as well.
- Question was asked: has the corridor trail been accommodated along Hwy 99. Need to figure out a safe crossing of the entrance to Scott Crescent.
- Question about habitat enhancement of the Mamquam Blind Channel. The developer is
  thinking that they will not do any work in the channel and alongside. Suggest that they
  consult with the stream-keepers and ensure that they are mindful of aging population's
  interests (birds, wildlife viewing). They are only showing a conceptual plan at this point,
  for a non-paved pathway (not a boardwalk) but there will be more detail as the application
  proceeds.
- It was suggested that a green building and energy conservation will earn them lots of points with the community.
- STS requested PDFs of the development proposal information. Developer does not think they will get a public hearing prior to the summer of 2011

#### **Updates**

#### Hwy 99 to Brennan Park Trail Study - Cascade Environmental - Bob

- Bob walked the possible route for the Commercial Way to Brennan Park Rec Ctr with the environmental consultant. The red-dotted route shown on the report is definitely the way to go, and Cascade will put forward a budget. Would include an equestrian standard bridge.
- Stephane reminded that the trail needs to directly connect with the neighbourhood on the

- east side of Loggers Lane. Would need a crosswalk across Loggers Land and north of Raven. Need to make an inquiry with DoS about pedestrian connection.
- Bob is suggesting that we should present the budget to the Council and ask them how they would want to proceed with plans for the future. Could consider leveraging DoS funds.

#### **Transportation Study - Carl**

- Carl couldn't make it tonight. He'll send some links and information to us.
- Open house happened a few weeks ago. Bob raised a concern that the premise of the transportation study is a decrease in the car traffic in the corridor in 30 years.

#### Report from Todd Pope - Updates on Issues in process

- Highway improvement discrepancies: Jesse Moorwood MoT emailed and wants to meet. Bob and Carl will meet with Jesse about this.
- Corridor Trail re-alignment of road barricades from Hwy 99 Mamquam bridge to past the dyke entrance. All this is in the works.
- Gov't Road/Brack School and Depot Rd. railway tracks Engineer Jennifer Chancey is charged with looking at all crossings.
- · Corridor Trail Valleycliffe: Red Point to Clarke Drive
- Teresan Gas loose gravel basalt on Discovery Trail. We should write a letter to DoS and
  Terasen about replacing the material, and propose that they fund us to do it. We paid
  \$15000 to upgrade it, and then they came in to adjust the line and did not bring it back to
  the standard.

#### Discussion - Projects for 2011

#### Cottonwood Park connector to the General Store - Stephane

- It's currently very muddy and slippery, crosses cottonwood creek. BOATA proposes joint proposal with BOATA and STS to improve the trail. Suggested that we could (opt) lay 4X4s and fill in with gravel crush but maybe not. Suggest landscape fabric / geotextile fabric. Would need permission from DoS since it's their park. It's about 400 ft, 5 ft wide. May be 2 full dumptrucks at \$300-350 each. Funding possibilities: STS, DoS, or store-owner?
- Suggest that Bob and Stephane will talk to Todd to make the connection. This could be a good Don Ross project?

#### Ray Peters Trail - parallel to Hwy 99 - tree planting buffer btwn trail and Hwy - Stephane

- In Whistler they had an arbour day where they plant trees, obtained seedlings from logging related outfits (timing is usually in the spring pine, spruce or firs), and get community help to do a one-day planting blitz like an arbour day.
- Would need to get permission from MoT, and would need big enough trees that they are not mowed down, and choose a species that does not grow too high.

## RPT - just off right angle corner of Squamish Valley Road, the section in the logged area - Bob

- It is very rutted, needs to have a proper trail bed built and surfaced
- This would be a good project as it has value for the Triathlon

#### Brush Back Brigade - plans for 2011

- A few suggested projects downtown:
  - o parallel to 6<sup>th</sup> Ave the dyke is very overgrown
  - o 7<sup>th</sup> avenue bridge downtown, just west of Eaglewind

Some florists have been harvesting vegetation from the estuary, and it appears that the authorities are onto them and will take action.

#### <u>Issue</u>

Golf Course trail head and kiosk - parking lot needs grading/ kiosk needs TLC

- There was a complaint in the newspaper about lack of maintenance of this area
- Understanding when it was built by John Harvey was that he would do the capital, funded by 2 companies, and the District would do the maintenance.
- John complained to DoS that DoS needs to get out there and do it. John contacted the Ops Manager to see about this, and get trails maps (maybe from SORCA). Suggestion was to ask Quest if they want to promo etc. John will investigate.

#### Edith Tobe, Squamish Watershed Society

- o Squamish Trails helped watershed society to apply to Squamish Credit Union / Van City for \$10,000 via charitable status
  - o April 13 announcement at 7pm at Squamish Credit Union all welcome!
- o Primarily grades 3,4,5 students have a field trip to the rivers component of their education. Targets about 600 students and is a fantastic program. Thanks Squamish River Watershed Society!

#### **Cottonwood Park**

- Stephane has been in contact with DoS Scott Lamont about the proposed trail upgrade.
   DoS is going to be upgrading the park anyway so it could be great timing.
- o Many years ago, Jas Michalski (DoS / DFO) had dialogue with reduced mowing to take care of the riparian area (?). Also there is Japanese knotweed. Edith will send a note regarding this.

#### Hwy 99 Discrepancy Discussion

- o Bob and Carl met with Jesse Moorwood (MoT staff) to review the discrepancies report.
- O Some items: safety of intersections, particularly Industrial and Commercial Way are a problem. Jesse said that STS must meet with DoS because these are DoS responsibilities. Members suggested that many alternatives should be explores, e.g. a crosswalk along Commercial Way between the roundabout and Hwy 99. This area (Commercial Way, Queens Way) will continue to get busier with new development.
- O Jesse will get back to us on signs positioning. STS noted and J. Moorwood will look at gravel erosion e side of Cleveland, south end of the Mamquam Bridge, dangerous situations for pedestrians all along and particularly between Downtown and Valleycliffe.
- o Corridor Trail should be completed this year (2011) and this will hopefully alleviate some concerns about pedestrian safety and pedestrian travel options.

#### Commercial Way to Brennan Park Potential Connector Trail Project

- o Bob will send the report to Todd that has been prepared and Todd will put it on Committee of the Whole. Then DoS can deal with the priority, cost etc. The report provided by Cascade indicated that the bigleaf maples would not need to be disturbed.
- Edith has talked with a sample of people who live in the area and thought that there are sufficient connections already. Also the fragmentation of the habitat in this area is also an issue. However there are also supporters of this trail connection, particularly adults and kids who are involved in sports at Brennan Park.
- Penny also noted lack of support to proceed with his new trail. Note: subsequent Apr
   11) email from member Mary Mitchell also noting lack of support for this trail.

#### Upper Mamquam Blind Channel (UMBC) Study and Development Proposal

Bob will send our previous correspondence about the UMBC to the planner on the project, Jim Charlebois.

#### MoT Hwy 99 Deficiencies

MOT meeting next Thursday April 28th regarding the deficiencies of the highway upgrade related to pedestrian and cyclists. Big concerns are Mamquam Bridge connection to Corridor Trail, Industrial and Commercial Way, south of Mamquam Blind Channel Bridge near KFC, and many more places.

#### **Cottonwood Park**

Cottonwood Park meeting regarding park upgrades and integrating the trail considerations / upgrades is Tues April 26th April at 11am.

#### **Commercial Way Connector**

There has been some email discussion regarding this trail, whether it is supported and should go ahead etc. The District has already received Cascade Environmental Consulting report (STS decided in Dec 2010 to commission the report) and if the District want to go ahead at some point in the future (near or far) then it would proceed. Now this trail is 'on the books' as a possibility should it want to be considered as a connector.

A lesson learned from this process is that we should consistently confirm our priority projects on an annual basis. This trail was identified as a priority a few

years ago, but perhaps it was not as highly desired when it made it to the top of the list for consideration.

#### **Squamish Outdoor Recreation Expo**

The "SORE" is taking place on Saturday April 30<sup>th</sup> at the Adventure Centre, 3 to 7 pm. STS will have a table to showcase website, get ideas about maintenance and new trail connections in neighbourhoods, memberships, draw (Penny has secured some draw prizes from local sponsors CORSA). Idea: post a volunteer job description for a Test of Metal Volunteer Recruiter/Scheduler.

#### **Brush Back Brigade**

There is a good weekday crew, and Bob is preparing a photo album to hopefully recruit a weekend crew for the Brush Back Brigade. The photo album will be on display at SORE, Test of Metal, etc.

#### **Test of Metal Food Booth**

Bob has met with the Campfire Grill regarding a proposal (they had approached the sponsorship group with Test of Metal) to work with STS on our fundraiser at TOM. If it proceeds, STS would get the pulled pork from Campfire Grill, and the buns etc would come from other places including donations. The food for non-racers would not be pulled pork.

Penny has committed to organizing the ticket booth, and Graham can help out. Graham will contact Penny.

We need a volunteer coordinator/recruiter for those helping with the barbecue – duties are to phone people and get their commitment, schedule. See note at beginning of the minutes, and volunteer 'job' posting at upcoming SOAR.

We will also need the Friday evening set-up crew (June 17) as per usual.

#### T-Shirts or Hats or Patches

We have explored STS-wear in October, but decided not to move forward. Discussion was revived about whether we were interested in STS wear. The idea of an apron was discussed heartily – 'a uniform to some, a soul apron to others.'

#### **Capilano University Student Trail Crew**

The student group completed a half-day raking project on Ray Peters Trail and reposted signs. Great progress!

#### **New Trail Maintenance Equipment**

It was moved, seconded and unanimously approved THAT

STS should authorize expenditure for a new trimmer, and if necessary face screens and a wheel-barrow to a maximum total of \$1,000.

# Ring Creek Bridge Crossing (Carpenters Son Bridge) – Equestrian Concerns

Yasmine pointed out that the Backcountry Horsemen group did their first ride, and found that the 'new' Carpenters Son Bridge is narrow and has two 45-degree turns, also you cannot dismount on the bridge or dismount and walk across the bridge. As a result the riders cut up their legs badly or are very unbalanced on their horse (if they move legs out of the way), teeter over Ring Creek as they cross on horseback. Bob suggested that Yasmine email the list of concerns and these will be forwarded to Todd Pope.

#### **Treasurers Report**

\$7,184 is our current balance. Year-end financial reporting requirements are in the works by Jen.

#### Ray Peters Proposed Upgrade (part of Triathlon course)

Upgrading the stretch near the Horth log cut next to Squamish Valley Road has been suggested. Scope of work and approach could be to contract a bobcat to create a proper trail service, and re-crush the powerline south to that point. Need to get a few quotes; there has been lots of great trail work done by various contractors lately in town. This work would need to be done in cooperation with Triathlon as it is part of the running course for the Bob Macintosh Triathlon in July.

#### Clarke Drive area trail connectivity

This is a difficult area, and it will be fixed up as part of the Corridor Trail project by District of Squamish. We could get an update from Todd on this.

#### **Squamish Trails Society Website**

STS has lots of affiliations; should we offer that groups can have an affiliation and presence on the STS site. This could be particularly beneficial for groups that do not have or want a website but may wish to have a web presence. Could also ass a list of related club links to our website.

### **Trail Use Code of Ethics**

Environmental Society is working on a code of ethics at the estuary edge at the Spit (Eel Grass "chellum" trail), and they want to get societies to put their logo on the sign (STS etc.) to show solidarity. More info forthcoming.

#### **Elections**

President and Vice President:

- Bob is stepping down as the President still wants to be involved in website, Test of Metal, etc. Squamish owes Bob a huge debt of gratitude for his many years of service. We need people to step up and take a role to continue the excellent and needed work.
- Could ask Capilano Collage video department if they are interested in doing a video project, encouraging trails leadership. Maaren will ask the instructor she knows about whether a student project could be a good project.
- Could do rotating chair as a temporary solution. Question was raised as to whether we need a listed President to fill the Societies Act's requirement.

# Meeting May 19, 2011 Squamish Trails Society Squamish Arts Council Building Cleveland Avenue, Squamish BC

Meeting was brought to order at 7:03pm.

#### Paradise Trails Dev.

Auli Parviainen, representing Paradise Trails Dev., discussed the project which is hoping to develop a piece of property in Paradise Valley with an equestrian centre and 83 building lots for housing, as well as 8 km of public trails. They are doing a Facebook campaign, hoping to raise awareness of their project. As well, they will be at the Test of Metal. For anyone visiting their website or the Test of Metal booth, they will donate \$1 to be used for that person's choice of group, ie. SORCA, STS, Equestrian Centre.

#### **Test of Metal Food Booth**

Supply and scheduling for the TOM food booth was discussed. This year we are serving pulled pork sandwiches, potato salad and coleslaw and a drink to the racers. It was decided to offer some of the pulled pork sandwiches and salads to the public for the price of \$10 (but not including a drink). Extra to be ordered. As well, we will be serving BBQ smokies and European wieners for sale to the public. New for this year will be a dozen clam-shell packaged green salads to see if they are a popular item. As well, we are hoping to sell coffee from 8:30 to 11:30 at the Civic Centre.

#### Ray Peters Trail upgrade

There are two sections of the trail that require a lot of work and Dream Wizards Events Ltd has provided quotes. For the northern section from the cemetery to the Horth woodlot, they propose to do the following for \$4,739.84.

- Clean up debris and stumps left by tree falling activity.
- · Elevate tread and promote good drainage for a long lasting trail.
- Bring 200m of existing rough single track trail up to Type 2 standards.
- Cap the finished trail with crushed granite and compact tread.

And for the section from the cemetery to Ross Road the following is proposed for \$9,866.08.

- Create proper trail drainage with grade dip and correct water damage.
- Elevate tread and promote good drainage for a long lasting trail.
- Install 4mx300mm plastic culvert to allow for proper drainage.
- Bring 400m of existing track trail south of cemetery up to Type 2 standards.
- Cap the finished trail with crushed granite and compact tread.

We have a preliminary commitment from SLRD to fund their portion of the Sea to Sky trail for \$5,000. As well, there is a possible \$3000 coming from the District. It was decided to proceed with these two sections, and STS would fund the balance that was left owing.

#### Corridor/Trans Canada Trail

Doug Morrison asked if we wanted Gord McKeever to attend a STS meeting to discuss and give an update on the Corridor/Trans Canada Trail. It was decided to wait until the Fall to ask him, as we are busy with the TOM final details at our next meeting, and summer is not well attended.

#### **Treasurers Report**

\$6,353.45 is our current balance.

# Meeting June 16, 2011 Squamish Trails Society Squamish Arts Council Building Cleveland Avenue, Squamish BC

#### Government Road, and ElementsArea - sidewalk, bike lane etc.

- Line repainting is proposed to be happening.
- Alignment of sidewalks and bike lanes, and crosswalks are an issue. Particularly in the Mamquam Bridge Government road area.
- Carl met with District staff (Greig Garland) about concerns and suggestions at Mamquam Bridge area. Need to build for the demographic in that area.

#### Ray Peters Trail – equestrian restriction and clarity

- Equestrian users SVEA are looking for some clarity about where horses are allowed on the Ray Peters Trail. The equestrian users concern is starting to lose presence on the trails due to a small user group in Squamish.
- Comment was made that casual horse use is really complementary from a user point of view, but some different design preferences between mountain bikers and equestrian users.
- Backcountry Horsemen and SVEA are more than willing to hep out with trails and hear feedback about their impact, they just need to be part of the dialogue about it.
- Callaghan Valley is doing a trial for equestrian riding this summer, and there will be horse camping out in Squamish Valley around Mile 14-ish near Camp Summit.

#### **Carpenter Sons Bridge**

- SVEA / Backcountry Horsemen made an inquiry about possible redesign to move handrails to the outside, which would have equestrian users' legs from damage. Will bring this suggestion to Todd.

- There may be a family river equestrian ride happening in August. Will keep us posted.

#### **Discovery Trail**

- Bob and Carl met with Jesse Morewood, Todd, and Sam from DoS.
- The problems are still existing and there has been no progress on the issues brought forward.
- There is a development proposal at the north-west corner of Industrial Way and Hwy 99. Vic suggested that the top layer could be removed and the lower layers are compacted and could be OK.
- DoS has closed the Discovery Trail bridge over Wilson Slough it has been vandalized / rotted. DoS has no money to fix it. Bob will make some inquiries about possible school project with Howe Sound Secondary School. There will be some wetland mitigation work in this area as well and it is possible that there may be some funds for bridge. Maybe Epic Truss would be interested in contributing, as this could be a truss bridge that is pre-fabbed and dropped in.

#### Inside Edge Tech Group's Proposal / Offer

- Offering their skill and expertise to work on a project for a sea to sky non profit group it's a competition, due July 31st.
- The application will be forwarded to members and any suggestions could be brought forward. Bob will also forward to Yasmine for SVEA information.

Meeting was brought to order at 7:12 pm.

#### STS Gondola Project

- There are about avg 500,000 visits per year (over the last 3 years) in Shannon Falls and The Chief (2 to 3 times the visits of other BC Parks). Avg visit is about 20 minutes – very short. There is captured visitation with the natural beauty but what lacks is tourism infrastructure that holds the visitor for a longer period of time that provides something for a lower-intensity (non athlete) visitor when they come to the Outdoor Recreation Capital of Canada.
- The previous Chief proposal for a gondola was a great idea, wrong space, maybe not too safe, not practical.
- A challenge with finding a site in the Howe Sound area was the high voltage power lines.
- The gondola would move people up to a higher alpine location, and have them stay there for a couple of hours that will leverage more time in Squamish and make it more of a destination than a road stop.
- The upper destination would be Habrich Ridge higher than the Chief.
- The base terminal would be on a 6-acre pad, zoning is Resource.

  Contaminant free. The gondola would go thru BC park, and into crown land area (previously logged) that is in SLRD jurisdiction.
- They are looking at two lift alignments and the criteria include least trees taken down, view/vantage point from the Peaks of the Chief Trail.
- The trail opportunities at the top of the gondola would be about 1km loops that give you different vantage points in various directions. Also, the 'upper terminal zone' at the top would also present opportunities for backcountry activities like mountain biking,
- Ground Effects has a letter from Squamish Nation that says they are intending to work together. Their objection to the previous proposal was the Chief itself.
- Crown lands is supportive

- BC Parks encourages them to go through the process because it could enhance the experience at the parks. There are safety issues, lack of parking, funding issues.
- Mayor and Councillors with Squamish and SLRD also appear to be individually supportive.
- Ground Effects have met with 25 groups, 6 public information sessions. Majority of input from the community has been supportive.
- Base area would have mostly parking: 380 parking spaces, buses etc.
- At the top: some food and beverage, a video experience, daylodge for events, classroom, etc.
- It would be a 6 to 8 minute ride to the top.
- Base area would provide opportunity for trail to connect Chief to Shannon Falls.
- They may apply to MoT for a southbound left-in. But, most traffic will come from the south via a right-in movement.

#### From a trails perspective:

- 1km grade friendly trail at the top plateau
- They might make a trail connection that would turn off from the Shannon Falls to Chief trail and follow the line of the gondola.
- Trail between the Shannon Falls and Chief park
- Climbing community wants to preserve and maybe also improve existing climbing opportunities to Habrich and Sky Pilot.
- SDBA is doing some trail work and have plans up in the Habrich and Sky Pilot area.
- There is some mountain biking from Goat Ridge.
- They may also look to some downhill mountain bike trails that would go from the plateau area down to Mamquam.

#### Questions and Responses:

- Intention is for year round.
- In winter there may be some tracked trail.
- A locals pass program is a possibility
- They are looking to do a bus based shuttle from the base to downtown to adventure centre. They would also like to make better pedestrian connections.
- Other rec opportunities may be rock climbing, wilderness camping, forest walk experience etc. They may get some licenses of occupation for smaller spot areas for these rec areas.
- If local businesses wanted to make use of the backcountry area, they could pay for the gondola. They could also get access via backcountry roads and access points to use the area up there Ground Effects would not have control over the whole area not like a ski area.
- Likely an 8 passenger tram. It will be a similar technology to whistler gondola from Creekside.
- Need to handle about 1000 people per hour

- Search and Rescue: dedicated helicopter area at base and top.
- At Sulphur Mountain they contract out locally for safety and rescue.

#### Order of approvals:

- 1. DoS rezoning at the base hopefully this fall
- 2. BC Parks Assessment one or more years This includes First Nations partnership. Will be a public process and involve environmental impact assessment.
- 3. Land Tenure & SLRD one or more years. This includes First Nations partnership.

Hope to be open by summer 2013.

They will likely bring in a strategic operating partner that are involved in tourism.

What is the future alignment of the sea to sky trail south to Vancouver – need to accommodate it via a letter.

It has been observed that ground nesting in the area has decreased due to dog traffic. The bridges have been removed once, and then it was replaced.

DFO sanctions the removal but they do not have the person power to do the actual removal.

Suggestion to make a media event and ask DFO to participate in removal as a community event, also to get the community input. It shows some leadership in

what are sanctioned trails and what are not. E.g. SORCA is removing unauthorized bridges.

Could salvage some parts of the bridge for re-use.

It is OK for STS logo to be put on the sign.

## Meeting November 17, 2011 Squamish Trails Society Squamish Arts Council Building Cleveland Avenue, Squamish BC

#### 1. Invited Guest - Rob Kirkham

- To speak about changes implemented in how the District relates about trails and to trails groups through its newly implemented Core Services Review process
- Councilors Race, Heintzman and Raiser were invited as well who are all current councilors seeking re-election
- Bob provided to Rob Kirkham a copy of DoS Bike Lanes Improvement Report accomplishments and recent concerns, and noted that a copy will be sent to District Council.
  - Rob noted that most of the concerns noted therein are being taken up with DoS Engineering staff.
- Bob noted that there are some changes to occur through the core services review processes that affect how STS will interact with DOS. STS is interested and concerned about it and has not had input to date.
  - e.g. Trails Coordinator Position is changed or ended? one concern noted by Bob. Rob said that the position has not been terminated, and he does not know whether it will be or not.
  - O Rob Kirkham explained that CAO initiated the core services review to make DoS work better. Fewer department heads with more direct connection to the CAO. Part of the re-org is to realign which functions belong where. STS is involved in off road trails, as well as on street bike lanes, planning issues. This is by no means a 'done deal', and DoS wants to receive input from organizations like STS to receive advice.
    - Member noted that STS is a champion for people who are not

- driving cars (non-motorized users) and using roads. STS is all about people moving around the community not in cars.
- STS has had trouble bringing forward this point of view to Engineering that are responsible for these projects.
  - Rob responded that part of the core services review is to ensure that Engineering does take responsibility for non motorized users, and that the community is engaged in it.
- Rob said that there will be a community advisory committee re STS issues, as part of the core services review process.
- Bob noted that in May/June we need to have budget requests done.
- Mike Nelson from SORCA noted that lots of mountain bike trails are outside of DoS in the SLRD and on crown land. Some governments are willing to match funds for trails but do not have full funding available. SORCA finds that another critical issue is that there is actually not a lot of land available for trails.
- Bob requested that STS be given an update and opportunity to provide input to DoS regarding the core services review.
  - Rob Kirkham responded that regardless of who is the new Council and relevant staff, there needs to be a sit-down.
  - Bryan Raiser suggested that there is not time to wait around, this work is happening now, and STS needs to get in touch with CAO and staff. Rob Kirkham suggested that instead STS should interact with Council because they are the lead who directs staff.
  - SORCA, STS and other groups are hearing rumours and are confused about what is happening on the inside. There is a lot of panic because it took so much work to get the Trails Coordinator position.
- Funding trails has been minimal and spotty over the years. Over the past few years there has been investment with the help of grants in the Corridor Trail and Bike Lanes.
  - Bob suggested that the DoS person responsible for grants needs to be applying for student labour re trails work over the coming 2012 summer.
  - Rob Kirkham noted that DoS needs to be ahead of the curve in terms of getting DoS 5-year work plan and priorities, so that when grant opportunities come up we are poised to move the projects forward.
- A member noted that when involved in DoS processes and projects (e.g. Multimodal Transportation Study, Corridor Trails Advisory Committee) there has been a lack of accountability back to the advisory group, and continuity before and after the plan and its implementation.

- O Rob Kirkham noted that Council reports often mention that there has been consultation with STS and other groups, but substantive comments are not included. Rob Kirkham discussed that Council needed to be involved in the process as it moves along. STS members suggested that consultation with community groups needs to be more robust and DoS-led, not just turning the developers loose onto the community groups and taking their word for it. And then user groups like STS get frustrated because the lack of consultation results in wasted and misplaced dollars.
- Discussion about the need to submit written input to Council ASAP to let them know that we are alarmed about the pending changes. Discussion that STS should send a letter cc CAO and addressed to Council to tell them how important the Trails Coordinator working relationship role has been to these groups and that this needs to be in place as the overhaul occurs. If this point person staff role does not exist in the future, then community groups will have to do a shotgun approach with staff and with council and the relationship will break down into whining and ignoring. We will ask for a response and engagement as well. Likely the letter will be co-signed by other trails interested groups like SORCA, and SDBA.

### 2. Skookum IPP Project (Mike Nelson in attendance)

- STS decided when consulted 6 months or so ago was the STS is comfortable with SORCA recommendations.
- A few weeks ago Bob was invited to and attended a Skookum Power meeting with SORCA and SDBA as well.
- As a result of the meeting, there has been more interest from Skookum Power in action. Skookum wants SORCA to sign an MOU with them. The project will have impacts on 13 trails, and the cost for rebuilding (\$500K). SDBA/SORCA have said that they looking for no net loss and a maintenance agreement (\$ amount in mind but not yet discussed, likely for the life of their water license). There are issues around timing for construction. Also issues around access and trails affected. There are going to be other logging operations happening as well next year (in the Skookum area). The IPP said that they are not able share lines for a number of reasons.
- Bob mentions that STS could use its non-profit status related to trail building, STS would take a 'donation' to hire a local contractor and administration surplus to do the trail work. Skookum would get a tax receipt. The benefit would be that we get to keep a local eye on the trail work. Mike will be bringing this to the SORCA sub-group dealing with this project and SDBA would also need to be on board. This proposition is tabled until January 2012, and when we hear back from SORCA/SDBA if they are interested. Matt will write some bullet points and will send on to Bob, then out to

#### SDBA/SORCA.

• Might the District consider expanding the boundary to capture the IPP?

#### Recent Crown Land - Squamish Nation announcement

- The Farside is on Parcel D near the DL 515 lot (Bob Fast property) MOU to occur.
- The area about Quest is a problem, it is now in trespass.
- Mike is meeting with Squamish Nation Council next week. Squamish Nation has said that they are looking long-term for housing development. Probably not a lot will happen in the short term. SORCA will talk with them about being trail stewards.

## 3. Highways Meeting

- MoT is looking at Industrial Way and Commercial Way.
- MoT gave DoS \$ to deal with the Industrial Way intersection and will look into a solution and get back to STS.
- Intersection refuge islands: STS to get back to them about how to address
- Mamquam River bridge- width of the sidewalk narrow and dangerous. Need to deal with this as well.
- The issue was raised and highways will not be dealing with the trail on north side of the Mamquam Bridge that drops down to the golf course.

# 3. Kingswood - Mamquam Blind Channel - on-site trail walk - Matt & Bob / Perry Beckham

- Following Matt and Bob's trail walk with Kingswood (developer & property owner) and Beckham (property owner), Perry requested a further meeting with Bob to express some concerns and sent a letter.
