# **Reports:**

Membership and mail-out: - thanks to Heather for recent mailout - "Happy New Year" and reminder to renew memberships.

Brushback Chainsaw Brigade: Vic – Dark Roast and Brennan Connector (tennis courts). **SVEA Report:** Nicole – deferred.

Financials: Jim - "fluent" in cash - report tabled. \$6500 spent of projects in 2018. Reminder to Hospital Hill park to maybe donate remainder to STS. What do we want to do in 2019?

**Smoke Bluff Park Committee:** Matt – email correspondence suggestion regarding complaint about private company using park entrance and access for their business. Suggested a physical barrier to prevent vehicles from parking on pedestrian areas from display to crosswalk (along drainage ditch). DoS looking into business lease for particulars. Lumberland Trail scramble with tree coming down and issues with assistance rope.





Introduction notes: Rotary Trail needs crowning, trees on Golf Course, Brohm Lake – bridges need work, In attendance: Vic, Patrick, Candy, Jim, Jack, Matt, Nicole, Helen & Jeff (SORCA), Carl, Laura, John Adoption of the Agenda: Moved by Patrick – carried. Adoption of the Minutes January 2019: Moved by Jim, seconded by Candy – carried.

# **Reports:**

**SORCA:** Jeff /Helen - reaffirm positive all together on the trail efforts – haven't really separated who's who in the woods for responsibility but generally SORCA on hills and STS on the valley bottoms. Discussion of how we us the "SORCA" trail crew. Looking at a change in staffing leadership – Dave Reid as lead now starting Feb (to December). What projects would we like to see done – particularly in "power tool shutdowns" and snow days. Funding from DoS for another 2 years. Has been some pushback from other municipal non-profits who question trail grant – looking at a fee for service model...

- **New Horizons Senior Program:** Jim met with DoS staff to ensure no conflicts, were some so have moved works to other places; met with Seniors to get volunteers to help plan and oversee sections; now needs to find health, fit vollies to move gravel long distances down trails getting Seniors involved with the community. \$25,000 grant approved. Intent to make trails accessible for wheelchairs, walkers etc. Volunteer ideas: competition amongst community groups most wheelbarrows?
- **Smoke Bluffs Park Committee:** Matt no meeting this month. Renewing delegates to update two-year terms. Shawn Gosnell to be STS rep with Matt as alternate. Trail improvement funding (Landluggers) approved for work this year. Suggestion of plaque for Chris McCrum acknowledging trail works.



**SVEA Report:** Nicole – had vandalism in arena – cars doing donuts. Looking at putting in a gate – DoS has placed rocks to temporarily "solve" the issue. Noted that trails at Legacy Park are not exclusive for "their" use. Public can use these trails. Horse club is eligible for grants for works – looking for ideas where they can get leverage with other groups and other grants. South bridge on Logger's Creek Trail would be a good candidate. Noted meeting with DoS to change Golf Course trail barrier to provide access for wheelchairs (both ends).



Trails Advisory Committee: STS and SORCA met with DoS staff to

develop a trails advisory committee to "help protect trail assets". Broad range of representation – walkers, bikers, horse groups, motorized users, accessibility group. Letter to DoS in support tabled.

Brush Back Brigade: Nothing serious yet on trails – noted shed has been moved, painting in the spring. Campground:

for kayakers. Jim – what about purchasing a display tent? Moved by Jim, seconded by Matt that we look into spending around \$300 for a shelter – carried. Nicole – what is our year term, is membership due and should she be getting minutes by email. John – discussion with DoS counsellors regarding abandoned campers. How do you deal with it as nobody will take them? Got to take them apart into small enough pieces to dispose of. DoS needs to develop a sani-dump!

Special Presentation: Robin Sherry (Search and Rescue for 10 years) – Mamquam Canyon Project. Idea to start new business, bringing more visitors, low impact, easy access for all ages, all weather - safe adventure for everyone. Saw a possibility to preserve an area that could be clear cut and provide education program regarding safety and preparedness (moving waters). Geology, First Nations, ecology education. 1.2 km boardwalk loop through the forest and along the canyon walls. Children's play area with sail canopies for rainy season. Looked accessibility for people and cars and away from other sensitivities. Questions: Ticket booth? \$20 to do the walk (tourist day user market) – seasons pass for families - \$20 + 5 for local residents. Will there be access to other trails? Crumpit Woods will not be impacted but signage will be upgraded in area to control hikers/bikers/visitors. Parking will be enhanced. What about kayak site? Don't see it being affected. Existing access point will still be accessible. Washroom facilities will enhance their experience. Will not affect Far Side/Power House Plunge. Boardwalk – in sensitive areas often too expensive/hard to do upkeep? Once built there will be low overhead (staff, energy, overhead) but there is a yearly maintenance budget. Want to be part of the site growing back to natural state and boardwalk seems to be the "natural" way to go. Wheelchair accessibility an issue giving the topography. Phase one the hope is to have certain points accessible. Future hope is to have specialized equipment and staff training to avoid exorbitant costs. How many visitors? \$32,000 covers cost with a bit of profit. Off season – school groups and educational programs – coordinate with local schools to see what is appropriate. Majority of canyon is above the falls and below the bridge. Will start build near bridge where the highest costs are. This will determine how much is left in the budget for the remainder. Existing parking area to be upgraded with some seating/picnic tables/parking for playground/coffee shop users. STS major concerns access to Far Side/Plunge and trails to Quest areas. Traffic concerns regarding dust. Goal to have well signed bike accessible trail from Quest to Cherry Lane and

eventually the Chief and the Corridor Trail. Road will be upgraded to extent allowed but the dust mitigation is

part of their budget (mag/chloride? How toxic is that stuff?) Not sure how many times a year that will need to be done? Question regarding traffic now and issues regarding conflict with various users on road – walkers, hikers, cyclists, motorcycles etc. Already lots of traffic and concerns and this project will make it worse ... Project wants to be part of the solution. Current speed 80km – can we bring the speed limit down? Have Crown Land tenure, going through zoning from residential to recreation, SFN involved (signed off during Provincial review), environmental review starting.



# **Reports:**

- New Horizons Grant (Seniors Program): Jim has sent back the 14 page agreement on hold waiting for the money. Intention is to smooth as many trails as possible starting in the Downtown/Estuary area and then to Mamquam. Spur Line crossing the biggest challenge update from SRWS meeting. Questions: money going into STS accounts for disbursement:
- **Brush Back Brigade:** Everything not growing yet. Nature Trail is packing in. Need to paint the shed. Thanks from Gwen in "darts and daffodils" re trail works. Do we need to track how many hours we volunteer individually? Wouldn't hurt! Hiking and trails about 50% of Adventure Centre inquiries. Their staff should have specific training about trails.



East Side/Grand Doug Trail in Smoke Bluff: Landlugger at work, John carrying fuel and not telling his boss they have started ... everything working out, except for the complaints and stop work orders as a result of social media. Resulting in improved notices/signage and happily no requirement for defibrillator! Lesson learned – consultation done but signage ahead of project could have been better. Note that DoS would have put out notices themselves if they had a heads up.



**Turtle Trail:** Alison McDonald has project ready to go regarding signage but having difficulty figuring out who to deal with at DoS. Meg met with Mayor to try and figure out who can move this forward. Will be working with DoS staff to develop "Great Canada Trail" signage. Alison is getting 150 signs but will interesting to see how this all works out. Turtle Trail is being flagged with icons – no reason why we cannot be doing icons for this as will. Would be a great benefit to go out for a ride to see what is possible. Is there anybody in Squamish who is now a champion for the Sea to Sky Trail? Maybe Trans Canada people




know. Meg doesn't mind pushing the wayfinding part of it since she is already chasing for Turtle and Corridor. Community Crawl summer ride coming up again and wondered if we want to do Turtle Trail or expand to (ie.) meet at Tantalus and go north, or to Gondola or? Is there interest in doing such a thing, being involved, moving it forward? Need to use trails within Squamish as leverage to increase STS membership. Note: DoS is now reviewing signage project as cost is prohibitive.

Looking forward to organizing dog poo event to set higher standard and accountability. More garbage cans is not the solution. Ordered some "nicer" dog poo bag bags. Planning to be at Earth Day booth with poo bag bags and Vancouver statistics. Might be appropriate to partner with Squamish CAN (Zero Waste).

- Nature Trail Progress Report: Jim spent \$3300 completed approx. %60 next work party April 26/27 9am start. Thanks to Muni for compacting ... thanks to Richard for that. AND, what about horses?
- Discussion non-slip surface for south bridge: Volunteer use on multiple locations no standing around <sup>(C)</sup>
  SVEA Report: Nicole re: Nature Loop how does the info get out to call for help? Planning for grant application in 2020 looking at Nature Trail south bridge. Discussion Brennan Park/Centennial way equestrian access and routing.
- Dog Owner Education: Laura planning to be at Earth Day
- BBB: Coat of paint on shed next projects? CH 4.5 hours on Ray's raked 350m.
- Campground and SBO Projects: John thanks to Matt and grade 5/6 with BC Hydro moving brush and chipping. Hopefully we will see a lovely story in the Chief! East Side Trail – Smoke Bluff meeting on Thursday. Controversy with mountain bikers – signage installed to inform/direct and clarify. Thanks to Landlugger – next challenge is to pay for it. Campground on annual 2 week shut down. Overwinter clients got out on time so it is all working out for May 1<sup>st</sup> opening date.



• Turtle Trail: Meg – physical trail moving around, last year DoS did 6<sup>th</sup> avenue area, this year hopefully. Wayfinding in process. Will be going out to do more flagging – need to sort out with DoS re marking on private land. May 14 Committee of Whole – Community Interpretation Plan – talk to Meg on Earth Day. Keely working on Community Crawl routes – three will be on Turtle Trail. Based on last years ride recommendations came forward.

Planning to meet one time in middle of town – Mamquam overpass – head north to Fergies/Sunwolf. Off road/not off road – establish priorities to bring forward. Then meet again same place and head south to Gondola. Information on Facebook page – Squamish Turtle Trail. Wayfinding – any money? Main route – Sea to Sky/Cross Canada is in place. DoS big wayfinding project not doing "year three" roll out but may have some money for small projects. Challenge is what is form and character that is appropriate?

- Financial: Jim assets almost \$45K with bills to \$8K need to spend some money? 🙂
- Smoke Bluff Park Updated Park/Trail Map: Table discussion of scope of park/map discrepancies. Discussion regarding "ownership". FMCBC wants to keep control on their parts don't trust that DoS will protect park designation and like to control mountain bike/trials bikes from "their" area. Discussion regarding expansion of park high priority to expand to Mamquam Blind Channel (acquire Drenka property). Trail issues: priorities projects east side trail had SORCA approval but small number of people not happy with crossing downhill lines. Previous committee members fought against multiple users in Park and were looking for restrictions.



# **Correspondence:**

- Chris Singer: Thompson Trail bridge repair deck and railings need some repair. Suggested that he come and make a presentation? Do we want to improve access to a trail that could be deemed as dangerous as the Brohm Lake area bridges are in poor repair. Do we want to set precedent that we are looking after Forestry infrastructure? Cost to repair \$85. Approved by show of hands we pay for material.
- Robin Sherry: Mamquam River Canyon project seeking letter of support for zoning change from RS-1 to Commercial/Rec. Needs to have some crafting to ensure there is protection for public access in the area. Noted

that the Mamquam run of river plant does have concerns regarding the number of people that will be attracted to the area. Discussion of merits of projects. There will be a public meeting for persons to express concerns and support. Moved by John that STS write a letter of support, seconded by Carl – carried.

### Special Guest: Claude-Anne Gaudbout-Gauthier; SSISC

Invasive Species: Council is non-profit covering Lions Bay to Darcy. Mostly seasonal grant workers, mostly students. Goal to minimize impact of invasive species in the Sea to Sky corridor. Because of large area plants and ecology can be different. Sea to Sky has three different areas (Squamish, Whistler, Pemberton). What we do: inventory, control and monitoring. Most treated areas along the highway corridor. Education and outreach an important component: training (landscapers, plant retailers) Native plants are not considered invasive – even though they are a nuisance. Some non-native species are not invasive because they do not present negative impacts. Invasive species are NOT native and have a negative impact on human health, the environment or the economy. Often invasive species lack their natural control measures (insects, predators, etc.) Cause habitat loss, harm to animal and human health, wildfire risk, erosion and stream sedimentation, reduced land values. Without efforts to contain their spread invasive species will double every five years. What can we do: "Play, Clean, Go": Clean your gear, pets, clothing, bikes and leave invasives where you found them. Remove plants, animals and mud from your gear and vehicles. Clean your gear before entering or leaving the recreation area and stay on designated trails. Use certified insect free or local firewood. Invasive animals: Don't let anything loose! Boats: "Clean, drain, dry!" Gardening: Be plant wise – do not compost, dispose of small amounts from your yard in the regular landfill garbage. Get involved, report, keep a lookout, learn to identify Squamish's worst weeds, monitor wetlands and waterways, volunteer (help on community weed pulls), receive training, sign up for SSISC newsletter. 

# Squamish Trails Society June Monthly Meeting June 18, 2019

In attendance: Matt, Meg, Vic, Jack, Heather, Carl, John,



Call to order: 19:04 Adoption of the Agenda: Moved by Jack – carried. Adoption of the Previous Minutes: Moved by Meg, seconded by Heather – carried.

## **Reports:**

- Senior Smoothers: Meeting June 19 at Coho Park equipment at 8am, gravel arriving at 9am. Note from Meg conversation with Andy Dawson DoS looking at works on dike north of railway park to improve gravel surface.
- Financials: Jack Notes from Jim: Sign/labels for Nature Trails tabled.
  Signing authority at bank: Noted that Shawn Gosnell coming off as signatory and Jack Hughes is going on in his capacity as co-treasurer, with Heather Evans and Jim Gracie staying on. Little change in financial report since last meeting all in good stead. Jim has also gathered a bunch of material on eBikes.
- **Brackentrail/Wonderland Connector:** About a month ago Jim and Shawn met with Polygon and SORCA. Polygon requested estimates with STS taking point and putting together RFPs which were sent to local companies. Have had walk throughs and initially waiting for estimates (due July 4). SORCA looking to move forward ASAP as they have some moneys that have time constraints. Two creek crossings will need separate approvals. Discussion of liability of Society if Polygon does not come through. Contracts will not be signed without money in the bank. Discussion regarding potential costings for an Estuary boardwalk.



- **Brushback Brigade:** Brake down on Vic's van drifted across the highway. Still awaiting bandaids and splints. Noted that Toboggan Trail needs a weedwacking!
- **Campground/SBP Projects:** John Discussions with Hydro to provide some fill for wet, nasty bits at "Neat and Cool Connector" stairs as part of remediation after pole replacement. Carl also noted required remediation of trail at base of Chief Apron where wooden transmission poles were also recently replaced.
- Turtle Trail: Meg two mirrors installed Mamquam Blind Channel highway bridge underpass. Sea to Sky Trail wayfinding component is apparently on hold at DoS. Thought on wayfinding – push up from "bottom" rather than top – accomplish low hanging fruit? Railway Park dike area - lots of private property will be indicated on markers. Also looking at slightly larger turtle markers for the back of signs and less expensive way to attach to street posts. Alternates discussed. Turtlers have been riding again – first group ride pretty darn successful - as well as recent ride with Sea to Sky Adventure including person using adaptive bike – very instructional!
- Smoke Bluff Park: Meeting a couple of weeks ago to walk "East Side Connector". Downhill riders concerned where trail crosses launch points. Walked alternate looking for options. SORCA looking at putting trail crew to do some remediation. Discussion regarding frustration with process as all understandings had been put in place prior to construction of phase 2. Smoke Bluff meeting next week will be asking various groups to put forward positions for further discussion/consideration. What is STS position? What will make the most folks happy? There is lot to be said for folks that go through the proper steps and channels. We need to work with all groups



but how long to we facilitate "rogue routes"? Discussions regarding safety – what can we do to pre-empt these problems in the future? DoS needs a policy. What do they advise? Park can control future development?

STS to support SORCA's construction of alternate line with the suggestion that launches are "decommissioned" until new trail is built – at which point the "phase 2" trail is decommissioned.

# Correspondence:

**DoS:** Richard – regarding mowing of town dike/deck replacement Swan Trail North.

Discovery Trail upgrades out to tender: Committee of the whole May 29 – Looking at 3<sup>rd</sup> Avenue as corridor through downtown to railway crossing at Bailey to Buckley to Highschool/Brittania Slough/Discovery Trail. This year building Corridor Trail like trail from Madill to Magee. Discussion of Industrial/Highway intersection – looking at fencing to prevent illegal crossing. No lighting from Finch to Adventure at this point. Clarke Drive rock pinch point: looking at/aware of but no breath holding for fast action or improvements. Also looking at top end of trail to Hospital crosswalk – trail will be delivered to intersection to ensure connectivity through new interchange to Waterfront Landing. Discussion also around future design along Pemberton Street– possible grade separation or no-posts – how does that work with snow?
 Benevity: electronic fund transfer set up for RBC.

#### **Business Arising:**



**eBike discussion:** Various complaints regarding speed as this becomes a growing part of the cycling demographic. Province as an extensive policy, classifying bikes and what areas they could access. Currently no restriction unless there is a specific limit put on specific areas by that area manager. Ease of climbing opening up more

areas. Discussion regarding safety with the biggest concerns being speed, speed and then speed. Trail etiquette a critical component and safety training

would be nice. A proactive solution could be some really good signage that talks about etiquette, safety, etc. Every bike shop should maybe have a quiz and maybe a test – every bike needs a bell! Message needs to be fun. Maybe plan for presentation with user groups – need pamphlet – how do you access the adults in the room. How do we address high speeds? Noted that Toboggan Trail needs a weedwacking!



**Corridor Trail Safety Signage**: If DoS isn't going to go ahead maybe we could do it and ask for forgiveness. Suggested that we communicate to DoS to suggest they put up 20k max signage – tabled. Carl to do some mock ups for next meeting. John to put together a draft letter.

Scooters? Do they have to have pedals to be on trails.

**Horses on Nature Trail discussion:** DoS doesn't really have a policy and considered non-motorized, multi-user. Hasn't been traditionally used in winter because very slippery clay surface just not safe. Horse community is trying to ensure restrictions are appropriate for uses. Access by horses is going to be very low – most opting towards the dikes. Concern is the late fall, winter and early spring, wet/frost months. There has not been any appreciable damage to this point.

Adoption of the Agenda: Note: add Senior Smoothers report and trail etiquette. Moved by Meg – carried.
 Adoption of the Minutes: Noted a couple of changes from those circulated previously. Discussion of routing. Moved by Jack, seconded by Meg – carried.

#### **Reports:**

**Brackentrail – Wonderland Connector:** Matt – Matt, Jim and Shawn met with Polygon, DoS and SORCA to discuss estimates that came in and to see if Polygon had the "appetite" to release funds. Polygon quite aways away from breaking ground but would like to leverage Trans Canada Trails funding. Noted that STS could provide tax receipt. Least expensive and most comprehensive just over \$200K which is a bit more that expected. Maybe start by looking at the bridges – prices ranged from \$10 to \$50K. Need to establish firm parameters for bridge requirements. Possibility of using Parks pre-engineered design. Question: Do they meet DoS "corridor trails" standards? What is the difference between "Corridor Trail" standards and "TransCanada Trails" standards? Noted that property at Depot has recently been sold and has already made "demands" for privacy fencing. At least some signage should be put in to ensure it was perfectly clear a trail was coming. Discussion regarding loading infrastructure salvaged on "Nexen" lands that could be repurposed for the bridge over Dryden Creek. Correspondence from STS to Cornerstone regarding possible donation highlighted profile and community goodwill etc.

**Financial**: Jack – met with Jim this week for "break-in period". First item on report is recognition of Jim's contributions! Well beyond the expectations of Treasurer's traditional roles. Second – note some changes as organization of report from Jim's standard. Discussion of accounting for "Senior Smoothers" grant within operating funds and project commitment line items. Storage Container Agreement Renewal and Inspection August 12-16. Renewal completed. Inspection requires that we do not store any flammables in storage or equipment.



5. Reports ;

a. Brackentrail to Wonderland ...Matt Parker tabled the latest events, stating that Dream Wizards bid has been accepted. Discussion about lowering cost should a suitable bridge be found that satisfies the municipal requirement and the builders needs. One possibility was the likely surplus steel bridge on the very south end of the Discovery trail. Matt described the draft MOU that has been tentatively agreed upon by Polygon and SORCA. This generated much discussion about the wording on cash flow and lead agency. Matt and Jack will rework the wording to show cash flow from Polygon to Dream Wizards and the fact that STS is the lead agency.

b. Financial report was presented by Jack Hughes. Heavy cash flow due to handling two \$25K grants. Our normal balance of funds remains as budgeted. It was agreed that the term deposit coming due in October should be moved into the operating fund. Jack and Jim will ensure that Squamish Savings is so advised.

c. BBB report from Vic Drought showed continuing weekly activity made possible by low fire risk. Assisted with Shoreline Clean Up last week and brushed back the Magnolia trail in Valleycliffe today. Next week, the Nature Loop north of the Adventure centre will be tackled...

d. Smoke Bluffs committee discussions were presented by Matt. That committee set a budget priority list which will include composting toilets, picnic tables and fire smart cleaning.

e. Kress corridor on berm running along the rear of lots on the north end of Tantalus road will cleared by DOS staff as flood refuge route. Some residents reportedly not happy with encroachment into their expanded backyards. This would be a fine link from Garibaldi Springs site to DeBecks hill trails either on or below the berm.

f. Brackendale Fall Fair was well attended and our booth was well received. Cash box came back with an extra hundred dollars..

g. New Horizons for Seniors Project "Senior Smoothers" has completed seventy percent of planned work to make more trails user- friendly for people using mobility assist devices. Jim advised that work on the South Dike trail will start tomorrow and that will bring the expenditures to over \$19K, leaving funds for Amblepath and the planned brochure. The final report to the federal government is due Feb 2020.

6. Business arising ;

a. Gasoline storage container is complete at a cost of \$334 and will be shared with SORCA.

b. Wellness fair is on 30 October and STS will share a table with Streamkeepers.

c. International Rivers Day will be held 22 September in McNaughton Park in Valleycliffe. Matt and Heather Evans are presiding.

7. Around the table.

a. A grant writer is needed to maintain our cash income. Membership and tee shirt sales will not cover the operating expenses nor allow for trail maintenance..

b. Centennial Way equestrian trail depends on future waterline towards the east.

c. Holburn Phase III mandates a community park northwest of Quest library. A link to the Highlands would be ideal and would need a pedestrian bridge over Mashiter Creek. The community amenities contribution needs to include this requirement before the contractor signs off.

# **Squamish Trails Society November Monthly Minutes** Wednesday, November 20, 2019 **Squamish Savings Community Meeting Room**

Adoption of the Agenda: Add Eagle Run dike update – Moved by Heather S – carried. Adoption of the Minutes: Moved by Meg, seconded by Heather S – carried. **Reports:** 

- Brackentrail/Wonderland Connector: Matt Matt met with Sandy McKay (November 20) as the two neighbours off Depot have expressed their displeasure with the plan and have produced a long list of demands regarding bridge placement, fencing/privacy and concerns regarding related works. Matt planning to with them on November 23. Noted there is no budget for fencing in proposal, though it was promised by Jim Harvey to previous owners when trail was originally being proposed. Challenges with location include position of existing private bridge, driveway and riprap retaining wall which may intrude on right of way – well worth cost of survey to clarify for future negotiations. Recommended that fencing costs should only be considered if there will be an overall cost savings involving bridge construction and only if there is a quid pro quo/trade off that values the project. Noted that some blasting on the pinch points has already occurred. Discussion of contract, moving forward and next steps. Action item: talk DoS to see if they would be willing to look at survey? Jesse Morewood DoS point person?
- Swan Trail Connector: Carl, Matt Discussion with DoS, Province, DFO regarding moving forward with trail improvements to ensure connection along Central Basin margin. Plan has been prepared by Mike Nelson of Cascade Environmental and submitted to all parties – looking forward to final approvals so works can be completed as expeditiously as possible.

Wellness Fair: Candy – lots of fun, lots of interest and questions – thanks to Penny and Candy!

- Brush Back Brigade: Vic Jennifer had suggested we document volunteer time in report to date 172.5 hours, 4.2 km of trails brushed back - does not include Senior Smoothers with additionally more than 240 hours of volunteer time and about 3 km of trails graveled (final tally in Jim's grant report); noted that storage shed access gate now by combination lock; equipment - need new brush blades!
- Campground/SBP Projects: John Smoke Bluff job (leveling at "Neat and Cool") hasn't happened yet... Awaiting availability of BC Hydro contractor.

**Turtle Trail:** Meg – checked out Sea to Sky Trail signage from Adventure Centre to Jack Webster bridge. Noted installation on a variety of "substrates" – wooden posts, sq. steel posts, street lamp standards, attached to highway signs – observed that signs that "double teamed" with other bicycle infrastructure signage most effective. Looking forward to how this project relates to future Turtle Trail as signage was put up by DoS personnel and not necessarily following formal trail signage standards.

Financial Report: Jack – (two months as October meeting was missed) Discussion of Benevity fund transfers through to SORCA; discussion of chartable status through spending ie. ensuring charitable donation funds are targeted and show appropriate deliverables - need to ask SORCA for reporting at the least to ensure appropriate oversight. Further discussion of how Benevity funds work ...


Action items; Meg to confirm with Keeley \$118 invoice for services toward Turtle Trail;

Action Item: John to email Hospital Hill Park folks to advise \$1318 left over in budget will be rolled over into STS "general revenue" unless otherwise directed.

Senior Smoothers Summary: Jim - deferred.

Christmas Communications: Heather – deferred.

- Trail Etiquette Signage: Examples tabled. Suggested a slightly smaller versions as poster for bike shop. Agreed that 8 signs produced would be installed on Corridor Trail between Adventure Centre and Brennan Park four in each direction. Thanks to all those folks who made valuable suggestions.
- Dike Reconstruction: Carl attended first stakeholder meeting November 19. Project broken into two areas with "Reach 1" being the Siyich'em reserve and "Reach 2" the eagle viewing area (watershed grill to "McIntosh" property. Three options in Reach 1 including 1. a reconstructed, higher retaining wall with land levels behind wall









staying at existing grade; 2. Infilling land behind dike to full height - would entail removal of all existing structures and reconstruction on top of propose fill that would slope to Government Road; 3. build a new dike from Fisherman's Park to the outfall of Judd Slough by the Watershed grill 30 m inland from the Squamish River's existing right bank. Existing pumps and fish passage structures at the end of Brennan Road would be reconstructed at the new outfall downstream. Noted that plans do not include public access across any dike that crosses SFN lands - option 3 would bypass the Siyich'em reserve lands. Reach 2 would be raised and widened with possible realignment of Government Road and enhance parking. Structures on top of dike would likely be removed and reinstalled at a later date. Part of proposal was for new structures including "social" seating and an observation tower. Also discussed was an "arrival gateway" and permanent public washrooms. From a Trails perspective it was highlighted that accessibility must be maintained and that the District's long term goal should be to negotiate public access along the dikes from one end of Squamish to the other. Also discussed making the Eagle Run dike area a "neighbourhood hub" – much like those envisioned on the Turtle Trail, including enhanced interpretive opportunities. One sticking point was alignment of Government Road which trespasses on the IR – it will likely be moved to the east which could include removal of some (if not all) of the walnut trees. All options have the dike being raised 1.5 metres – not specific time line but after development of final master plan it is anticipated it will take 3 to 5 years if the District is successful with grant applications. If not it could be a longer, phased project. There will be a public meeting December 5 from 6 – 8pm at the Adventure Centre. More

and survey of Depot Road trail access and service poles. Moved by Jim, seconded by Candy – carried.


### **Reports:**


- **Brackentrail Wonderland Connector:** Matt been working with Ted on some of the rock work on south end, playing with rock drill and expanding rock cracking rock. Trail proceeded up DoS road access and heads north across talus slope almost to the "flats" (330 meters done so far – of about 1.2km) Discussion of survey showing poles on middle of right of way. Discussion of process and moving forward on north end. Bridges have been ordered (aluminum "gang plank" style structures). Creek crossing 45 day regulatory notice in place – negotiations for access for installation ongoing.
- **Trail base material for Swan Trail on Bailey Rd:** Carl / Matt back and forth with Cascade/Dos/Province resulted in "change order" need legal access from property owner, likely BC Rail property? Cost of process ~\$1500. Another option might be to remove all material from sensitive area and bolster north and south to avoid the "wet bit". Discussion of who owns
- the land and jurisdiction. Campground & SBP Projects: John – Smoke Bluffs "Car Park Crags" area access
- being improved by DoS "night crew". Long term plans for play area, wheel chair accessible and easier "kid friendly" climbs. Discussion of park mandate to increase capacity and the required sensitivity to other users. Hospital Hill Play Park leftover funds could be used to purchase a concrete picnic table. Moved by Heather, seconded by Candy, that STS contribute up to \$400 additional dollars to the existing Hospital Hill Play Park for purchase and installation of picnic table – carried.



**Financials:** Jack – December report tabled. Noted that we have not received any significant grants or donations in the past several months – so we will at some point need to consider ways to raise additional funds. Discussion of "New Horizons for Seniors" (Senior Smoothers) grant expenditures and commitments. Discussion of future project to upgrade trails, such as across "Westwind" West Barr remediation site (or others) and how that process might work to have successful grant applications – targeted proposals with initial costing estimates. Discussion of moving forward with campaign to solicit donations and membership drive. Need to have a list of organizations to target for contributions at year

end. Do we want to advertise, or develop such a campaign or ? Definitely before our next AGM we need to look at such a plan that could be presented. Need funding for general operation of Society and other for special projects. DO need to promote the Society and encourage membership and participation. Meg – had hoped community rides would also encourage both participation and membership. Could start with walking groups? Could be a letter to the editor or even a paid advertisement – Jim's columns were a great contribution. Maybe take better advantage of newsletters and social media. Noted that real estate agents use trail network as sales pitch – need to target those folks – Jack suggested he could approach Mike Carney.





Senior Smoothers summary: Jim – roughly \$1700 left for pamphlet. Total impact 7 km of trails – most money spent on Nature Trail and Estuary Heron Trail. Noted that we do need to have a "ceremony" of sorts to "open" the improved trail. Suggested we could do in estuary or at Adventure Centre near Nature Trail work and contact Mayor's office for commitment to have a January event. Matt will contact the Mayor. Noted if held on Heron Trail inaccessibility for those in wheel chairs would be highlighted because of the CN tracks... group of wheelchairs trapped on other side...



### **Correspondences:**

- **Concerns from Depot Road resident(s):** Several different offers put forward to alleviate concerns regarding fencing, privacy best option to offer financial option so that property owners are responsible for construction and long-term maintenance. Discussion of revenue stream. Question asked is there an opportunity of volunteers to assist? Maybe later as terrain is pretty extreme... Is there anything we should be doing as far as community/membership messaging updates could be offered with Ted's blessings? Might be better to just get it done and not encourage "looky loos". Comment from John regarding offer to provide privacy fence noted that original offer was probably to move the project along. Agreed that it is better to have private fences built by private property owners Individuals can assist...
- **Meeting with DOS Staff:** Request from Matt was put forward by email waiting to hear back noted that we need to plan for October meeting in the future.
- **Business Arising:** Discussion of providing feedback to DoS regarding trail needs and suggestions take a picture that we can forward. Can also provide "daffodils" in the Chief. Great value in thank to DoS to acknowledge their efforts.
